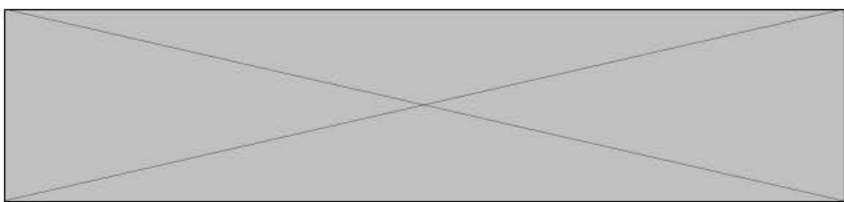

### **Attorney General Merrick Garland Delivers Remarks for the Reproductive Rights Taskforce**

#### ***Remarks as Delivered***

Thank you, President Biden. Thank you, Vice President Harris, for bringing us together today. Thank you, Jen. And thank you, Secretary Becerra, for highlighting the urgency of this crisis, and for your partnership.

In the five weeks since the Supreme Court overturned *Roe* and *Casey*, legislatures across the country have taken steps to impose bans and other restrictions on access to abortion, with devastating consequences for women's health, their safety, and their civil rights.

And we know that the harms caused by these laws have been and will continue to be especially severe for people of color and for those of limited means.

Since the day that *Dobbs* was decided, the Justice Department has made clear that we will be relentless in our efforts to protect and advance reproductive freedom.

As we have said repeatedly, women who reside in states that have banned access to abortion must remain free to seek that care in states where it is legal.

Under fundamental First Amendment principles, people must also remain free to

inform and counsel each other about the reproductive care that is available in other states.

States may not ban the abortion medication Mifepristone on disagreement with the FDA's expert judgment about its efficacy and safety.

And federal agencies may continue to provide reproductive health services to the extent authorized by federal law.

Last week, I also said that the Department is vigilantly monitoring state laws and enforcement actions to ensure that states do not infringe on federal protections of reproductive rights.

And I said that when they do, we will consider every tool at our disposal, including filing affirmative cases, statements of interest, and intervening in private litigation.

Yesterday, the Justice Department filed a lawsuit against the State of Idaho to hold invalid that State's criminal prohibition on providing abortions, as applied to women who are suffering medical emergencies.

As we explained in our complaint, Idaho's near-total ban on abortion directly conflicts with the Emergency Medical Treatment and Labor Act, or EMTALA. That federal law requires hospitals receiving Medicare funds to provide necessary stabilizing treatment to people suffering from an emergency medical condition.

As I said when we announced this suit, it does not matter what state a hospital subject to EMTALA is located in.

If a patient comes into an emergency room with a medical emergency jeopardizing the patient's life or health, the hospital must provide the treatment necessary to stabilize that condition.

And this includes abortion when that is the necessary treatment.

Any state law that prevents a hospital from fulfilling its obligations under EMTALA violates federal law.

The Justice Department will also be filing a motion to dismiss the Texas lawsuit challenging HHS's guidance under EMTALA. The law could not be clearer, and we are going to vigorously litigate this suit to ensure women get the emergency care to which they are entitled under federal law.

Led by Associate Attorney General Vanita Gupta, the Department's Reproductive Rights Task Force will continue to build on these efforts to protect reproductive freedom.

Its work includes monitoring state laws that infringe on federal constitutional protections, evaluating appropriate actions in response to those laws including filing lawsuits and statements of interest—and coordinating technical assistance to both Congress and the States on federal constitutional and statutory considerations.

Five weeks ago, I promised that the Justice Department would work tirelessly to protect reproductive freedom, and that we would not waver from our founding responsibility to protect the civil rights of all Americans.

That is what we have done, and that is what we will continue to do.

As president of the nation's largest Catholic civil rights organization, I am requesting that you immediately deploy the full resources of the Department of Justice to apprehend and prosecute domestic terrorists who have recently attacked Catholic individuals, vandalized Catholic churches and torched Catholic-operated crisis pregnancy centers.

We have witnessed a rash of vandalism against Catholic churches, firebombings of crisis pregnancy centers (many of which are run by Catholics), Masses being interrupted, illegal protests outside the homes of Catholic Supreme Court Justices, and an attempted murder of one of the Catholic Justices. While there are several groups involved in these attacks, none is more dangerous than Jane's Revenge.

Jane's Revenge is a domestic terrorist group, par excellence. Recently formed, it brags about blowing up crisis pregnancy centers. Worse, it is calling for a "Night of Rage" on the day the Supreme Court is expected to overturn *Roe v. Wade*.

Jane's Revenge made its first public statement on May 8, following the firebombing of a crisis pregnancy center in Madison, Wisconsin. It demanded that these facilities be shut down, pledging to destroy them if they remained open. It ended by saying, "We are not one group, but many. We are in your city. We are in every city."

It was on May 30 when it issued its "Night of Rage" threat. "On the night the final ruling is issued," it said, "we are asking for courageous hearts to come out after dark." It said it had chosen "a time of 8pm for actions nationwide to begin, but know that this is



just a general guideline."

On June 14, Jane's Revenge issued another online post, citing operations in 16 cities, as well as in "countless locations invisibly." Saying that "it's open season" on "anti-choice" groups, it pledged to "never stop, back down, slow down, or retreat." It sent a message to pro-life entities saying, "Eventually your insurance companies, and your financial backers will realize you are a bad investment."

On June 16, it said it would continue to destroy crisis pregnancy centers like the one in the Minneapolis-St. Paul area.

Reportedly, the Bureau of Alcohol, Tobacco, Firearms and Explosives is investigating Jane's Revenge. The Department of Homeland Security's National Terrorism Advisory issued a statement on June 7 saying, "The United States remains in a heightened threat environment," noting that "faith-based institutions" are among those being targeted.

On June 16, the FBI admitted that it is investigating these attacks on pro-life and faith-based institutions, though it did not say which groups it is probing. Assumedly, Jane's Revenge is at the top of its list.

We have learned, from credible sources, that there is a link between Jane's Revenge and Antifa, the far-left anarchist group. Their modus operandi and goals are very similar. Together, these two loosely organized terrorist groups pose a grave threat to democracy.

Sixteen senators wrote to you on June 7 asking for information on what the Justice Department is doing about these attacks. I applaud them for their interest, but we are beyond the point where data gathering is sufficient. We have now reached the stage where probes are academic. The clock is ticking.

We need aggressive action against those who have not only taken credit for violence across the nation—they are pledging to engage in more of it. Jane's Revenge fits the bill in both instances. The "Night of Rage" that it is threatening must never be allowed to commence.

Please take immediate action to see to it that these threats never materialize.

Catholic League president Bill Donohue [sent a letter to the chairman of the House Judiciary Committee today](#) requesting an investigation of those responsible for attacks on churches, pro-life activists and crisis pregnancy centers, with a focus on Jane's Revenge. Here is his letter.

Dear Chairman Jordan:

In my role as president of the nation's largest Catholic civil rights organization, I am asking you to convene an investigation into the reluctance of the Department of Justice and the FBI to pursue those who have engaged in violence against churches, pro-life activists and crisis pregnancy centers.

With the exception of the recent indictment by a federal grand jury of two persons charged with attacks on crisis pregnancy centers, little has been done to prosecute those guilty of such crimes. Indeed, the relaxed response to attacks on those in the pro-life community who have been victimized stands in stark contrast to the aggressive pursuit of the few instances of alleged violations of the law by pro-life Americans.

Last year, I [wrote](#) to U.S. Attorney General Merrick Garland about this issue,

asking for a probe of the multiple attacks on churches and pro-life facilities (see the enclosed). Specifically, I asked the DOJ to focus on Jane's Revenge. I received no reply.

To assist you in this effort, I am sending a [report](#) on Jane's Revenge that we have done. Thank you for your attention to this matter.

### **Pennsylvania Man Indicted for Assaulting a Reproductive Health Care Provider**

A federal grand jury in Pennsylvania returned an indictment today charging a local man for assaulting a reproductive health care clinic escort in Philadelphia.

According to court documents, Mark Houck, 48, of Kintnersville, Pennsylvania, is alleged to have twice assaulted a man because he was a volunteer reproductive health clinic escort. The two-count

indictment charges Houck with a violation of the Freedom of Access to Clinic Entrances (FACE) Act, which makes it a federal crime to use force with the intent to injure, intimidate, and interfere with anyone because that person is a provider of reproductive health care.

The charges stem from two separate incidents on Oct. 13, 2021, where Houck assaulted the victim, identified in the indictment as “B.L.,” because B.L. was a volunteer escort at the reproductive health care clinic.

If convicted of the offenses, Houck faces up to a maximum of 11 years in prison, three years of supervised release and fines of up to \$350,000.

The FBI Philadelphia Field Office investigated the case. Trial Attorney Sanjay Patel of the Civil Rights Division and Assistant U.S. Attorney Anita Eve for the Eastern District of Pennsylvania are prosecuting the case.

*An indictment is merely an allegation, and the defendant is presumed innocent unless proven guilty.*

### Justice Department Secures Agreement to Protect Access to Reproductive Health Services

The Justice Department announced an agreement today with defendant Daniel Courney to resolve a federal lawsuit filed against Courney for his alleged violations of the Freedom of Access to Clinic Entrances (FACE) Act. The FACE Act protects the right to access and provide reproductive health services, including abortion.

The FACE Act prohibits anyone from using force, threats of force or physical obstruction against any person seeking or providing reproductive health services. The complaint filed against Courney alleges that he violated the FACE Act on two occasions in October 2021. In both instances, according to the complaint, Courney used physical force against a patient escort at a health clinic in Englewood, New Jersey, to attempt to prevent the volunteer from assisting individuals seeking the clinic's services.

The proposed consent decree, which still must be approved by the U.S. District Court for the District of New Jersey, orders Courney to stay away from the clinic permanently, prohibits future FACE Act violations and requires Courney to pay a monetary penalty.

"Reproductive health care providers must be free to carry out their work free from interference or intimidation," said Assistant Attorney General Kristen Clarke of the Justice Department's Civil Rights Division. "The Justice Department is committed to enforcing federal law to protect providers and all people seeking access to reproductive health care across our nation."

"Access to reproductive healthcare is a fundamental right," said U.S. Attorney Philip R. Sellinger for the District of New Jersey. "Individuals must be able to access facilities like the Englewood clinic to make decisions about their own bodies, health and futures, in consultation with health care providers. Those providers are entitled to offer services free from the threat of violence against them. Our office remains committed to the enforcement of the FACE Act throughout the District of New Jersey to protect these important rights. We encourage anyone with information about potential FACE Act violations to contact our office."

The Justice Department is committed to the protection of reproductive rights and recently announced the formation of its [Reproductive Rights Task Force](#) to protect those rights nationwide.
